RESOLVED: (unanimously) to approve purchase 2 x Heavy duty locks for the two park gates.

#### **Pavillion –**

RESOLVED: (unanimously) to approve to purchase corners for the guttering.

Clerk and Asst Clerk will look to work on clearing and sorting changing rooms in Pavilion over Summer to tidy and create better use of space.

Cllr Moore and Clerk to investigate costs of extra CCTV around MUGA courts and Pavilion.

Cllr Moore to reach out to Bayfield's to gain access to CCTV for Clerk – Clerk has now completed this action.

Clerk to investigate cost of Water fountain for the park and bring findings to Full council meeting.

**Groundsman equipment maintenance** – Clerk to speak with Melton Mowers to agree a maintenance contract for the ride on mower and other park maintenance equipment. – Clerk has now completed this action.

Budget to be set for Roger (Groundsman) with spend approval from Clerk. This will be agreed at next Full Council Meeting.
