- i. To rescind all other appointments, designated powers, spending authority, and powers of attorney granted to the present clerk up to 23.59 on 10th July 2023. To appoint David Lines as Locum Clerk, Proper Officer, and Responsible Finance Officer with effect from 00.00 1th July 2023 until further notice. This appointment will expire 12 months from this appointment unless extended by full council or rescinded by full council.
- ii. To appoint Michael Stevenson and David Moore as unpaid Deputy Responsible Finance Officers.
