#### **Public Forum**

# Skate Park

- A member of the public supported the resolution for the Skate Park (agenda item 11a)
   he has three young children and would value such a facility within the village, as he believes, would all of the public attending the meeting tonight.
- Another member of the public added that the Government talks about obesity of the young and this skate park proposal is a great opportunity to put in place an active leisure facility within Rendlesham, which youngsters could walk to (not reliant upon travel by car to Woodbridge) commenting also that there isn't much else for youngsters to do within the village
- A member of the public asked for the Council's thoughts on the location of the skate park in light of any future development within the village (i.e. avoiding any later

relocation expenses). The Chairman replied that no decision has been taken on location. This will be a matter for Full Council and Jubilee Park Committee if the resolution is passed.

- When asked if the Council has made any decision on construction, the Chairman replied that nothing has been determined as yet, just ideas. There will be a consultation in due course ideas from the floor for communicating that consultation to the youth of the village included smart phone messages, youth club promotion, social media and the Rendlesham Community Face book page (for parents).
- Councillor Bond expressed his wholehearted support for the skate park project commenting that the project is both desirable and feasible for Rendlesham's youth.
- The Chairman confirmed the skate park resolution could be moved up the order of business

#### Woods Lane Closure

- A member of the public asked for clarification on 'consultations with local residents' in a recent MP's letter. Cllr Nicoll replied that:
  - o the County Council had insisted Bloor consult with local residents.
  - The survey result concluded the neighbouring residents do not wish to see extended working hours in order to bring forward completion of the building works.
  - Suffolk County Council will maintain pressure on Bloor to complete all work asap
  - The main sewer works are expected to hold the developers to the original timescale.
- Cllr Nicoll was asked if Suffolk County Council will reinstate the back roads damaged through use as unofficial diversion routes. Cllr Nicoll is happy to do so maintaining pressure on Bloor Homes to absorb these additional costs.

# County Councillor Report

#### Cllr Nicoli reported:

• Woods Lane – given the Woods Lane update (above) the next major issue is the handling of the Bloor Developments Community Infrastructure Levy (CIL) coming to Melton Parish Council. CILs may be used for the benefit of the wider community. As a number of Parish Councils have been affected by the work, as the wider community Rendlesham Parish Council might consider asking SCDC how the CIL will be distributed. What will it be spent on? As the Woods Lane development will add to pressure on local schools, might the CIL monies be spent on extending local education facilities?

- School Transport The County Council budget consultation is coming to an end.
   School Transport remains a concern and further public debate is expected. He anticipates RPC will want to make a statement.
- Skate Park He is happy to endorse the project and urges RPC to write to local businesses as well as local organisations for funding contributions.

# **District Councillor Report**

# Cllr Bond reported that:

- Woods Lane it should be remembered that SCDC did not grant the planning permission; it was a government level decision.
- Collection Services for Garden Waste<sup>1</sup> the real underlying problem is the Government burdening local councils with additional duties without commensurate funding. SCDC currently spends in excess of 17% of its Council Tax on the nonessential service of processing organic waste when 5700 households have no garden. Processing organic waste will inevitably become a chargeable service.

#### 11. RESOLUTIONS

(a) Skate Park Location

# It was noted that:

- Jubilee Park is the only land owned and available to Rendlesham Parish Council.
- The Council is still working to the Jubilee Park Master Plan and the skate park
  proposal sits within that plan and whilst it is not a central location within the village,
  the Park is the most likely location.

<sup>&</sup>lt;sup>1</sup> Suffolk Coastal District Council is proposing to introduce a charge for collecting garden waste from homes during the next financial year (2018/19).People in Suffolk Coastal will be given the option of paying an annual charge of £43 per garden waste bin (the equivalent of paying about £1.65 per fortnightly collection). They will also be given the option of receiving a replacement free larger (240litre) bin for their garden waste, during the first year of the scheme.



- If there were significant changes the Council could reconsider any decision as to where to locate the Skatepark. The Council meanwhile will be mindful of issues of construction size and noise in Jubilee Park.
- The resolution, if made, would give authority to the Jubilee Park Committee to proceed in deciding a location without recourse to Full Council

IT WAS RESOLVED to approve the installation of a skate park at Jubilee Park and give delegated authority to the Jubilee Park Committee to take the project forward to completion.

(b) 5-a-side football pitch project

IT WAS RESOLVED to allocate the £20,000 from Bentwaters Park to the 5-a-side football pitch project

ACTION: Cllrs Harding and MacGregor to arrange meeting with SCDC.

 Speed Watch The Clerk has volunteered which now makes up the numbers for a Rendlesham team to operate

ACTION: Confirm the Clerk is undertaking her Speedwatch role as a volunteer only outside of her role as Clerk

7. BOTTLE BANKS Bottles are accumulating in the area of the former bottle banks. This has been reported to the landowner and passed to Suffolk Coastal Norse to follow through with their enforcement team. The Clerk has been in discussion with the owners of Rendlesham Mews who have returned with the question 'will the Parish Council contribute up to £1500 towards hardstanding with a form of licence of occupation to host a bottle bank site?' The challenges of the Mews site include accessible footfall and traffic safety exiting to/from the highway. The Mews was the next best site following previous site assessments within the village and it does permit a recycling facility in the village.

ACTION: Enquire about ongoing licence fees with the Mews land owner.

IT WAS RESOLVED TO contribute up to £1500 (or 50% of the cost whichever is the lesser amount) of the costs to install hardstanding to accommodate space for 4 bottle banks subject to confirmation there will be no ongoing fees or costs for drawing up the licence to occupy

The Finance Committee therefore proposes an increase of £2.63 per week per council tax band D property.
